

GREATER VICTORIA FLOWER COUNT 2023 PHOTO CONTEST OFFICIAL RULES & REGULATIONS

1. DATES

The Contest will begin on March 6, 2023. The Contest will end at 15:00 PST on March 17, 2023 (the "Closing Date"). One winner will be selected at random from all eligible entries. The winner will be notified via direct message on March 17, 2023.

2. ELIGIBILITY

The contest is open to any Canadian (Excluding Quebec) over the age of 18 years who enters the contest by providing Greater Victoria Flower Count with their username and associated data and consent via www.instagram.com. Entrants must have a public Instagram account.

Misrepresentation of age or residency will disqualify the submission. The following person(s) are NOT eligible to win the contest: (a) employees, members of the Destination Greater Victoria Board of Directors, individuals employed or appointed by the Ministry of Public Safety and Solicitor General, contractors, agents and/or representatives of Greater Victoria Flower Count, advertising and promotional agencies, from July 1, 2019 onwards; (b) members of the immediate family (defined as a mother, father, brothers, sisters, sons, daughters and husband or wife), or any person with whom they are domiciled, of any individual described in (a); (c) anyone who has won a Greater Victoria Flower Count contest since June 30, 2022; and (d) anyone residing in a jurisdiction in which contests of this nature are prohibited.
